- The funds shall be utilized strictly for the purpose for which the funds have been released under the Centrally Sponsored Scheme of Vocationlization of Secondary & Higher Secondary Education.
- 2 Deviation of funds from one subject of expenditure to another is not allowed under any circumstances.
- The funds shall be utilized after observing all the codal formalities and following GFR-2017 rules
- 4. An amount of Rs. 24,000 per school is released /authorized in favour of Govt High Schools approved under Vocational Education upto AWP&B of 2018-19 @ Rs. 1000/-per Guest Lecture per class per trade where vocational Education is being taught in both clases 9th &
- 5. An amount of Rs. 8,000 per school is released /authorized in favour of Govt Higher Secondary Schools approved under Vocational Education upto AWP&B of 2018-19 @ Rs. 1000/-per Guest Lecture per class per trade where vocational Education is being taught in all the classes 9th to 12th.
- 4. An amount of Rs. 12000 & Rs. 24,000 per school is released /authorized in favour of Govt High & Higher Secondary Schools respectively approved under Vocational Education in the AWP&B of 2019-20 to 2021-22 @ Rs. 1000/-per Guest Lecture per class per trade where two trades approved by the Ministry of Education, GOI, and vocational Education is introduced this year and will be taught in class 9th in High School & in classes 9th & 11th only in Higher Secodary SChools in current Academic session.
- 4. An amount of Rs. 6000 & Rs. 12,000 per school is released /authorized in favour of Govt High & Higher Secondary Schools respectively approved under Vocational Education in the AWP&B of 2019-20 to 2021-22 @ Rs. 1000/-per Guest Lecture per class per trade where only one trade approved by the Ministry of Education, GOI, and vocational Education is introduced this year and will be taught in class 9th in High School & in classes 9th & 11th only in Higher Secodary SChools in current Academic session.
- 6. Minimum of 4 and maximum upto 8 Guest Lecturers per trade needs to be conducted for each class.
- 7. A separate cashbook shall be maintained for vocational Education and shall be periodicaly maintained for inspection by the audit teams/Officers from Directorate of Samagra Shiksha/ from this office.
- 8. All the vouchers/bills/reseipts shall be preserved in original after being signed by the concerned VT and duly attested by the Head
- 9. The funds released for the purpose shall be utilized before the culmination of the financial year 2023-24 and accordingly furnish the utilization certificate to this office before the culmination of the financial year 2023-24.
