An amount of Rs. 20,000 per school is released /authorized in favour of (i) all the Govt Higher Secondary Schools approved with single trade during 2022-23 & 2023-24 (ii) all the Govt High SChools where two trades have been approved by the Ministry of Education , GOI during 2022-23 to 2023-24 & (iii) Govt High SChools approved with single trade during the 2019-20 to 2021-22 for conducting the inductrial/exposure visits.
